#### Who We Are

The Sanctuary at StreetLightUSA is a residential behavioral health program specializing in trauma healing from child sexual exploitation (CSE). Clinical services include therapeutic care for co-occurring symptoms and behaviors, to include trauma-fueled maladaptive behaviors, attention/concentration difficulties, anxiety, and mood challenges. Additionally, we provide support with secondary issues related to substance use and eating disordered behaviors while clients are on their trauma healing journey with us. Integration of family support and family therapy are also core components of our holistic model of care.

Our services are inclusive, integrating cultural and diversity based dynamics into each child's clinical care plan.

#### Services Offered



### Admission Criteria

- · Female at birth
- Ages 13 17
- Confirmed or highly suspected history of CSE.
- Medically cleared, including clearance from illegal and/or unprescribed substances and/or alcohol at the time of intake assessment and admission.
- Mental status examination shows intact reality testing and full orientation, with no indication of current dissociation and/or active psychosis and delusions.
- Referent agrees to all policies and procedures, to include all integrative services and academics that comprise SLUSA's trauma-informed holistic treatment model.
- Danger-to-self factors are limited to ongoing and/or pervasive intrusive thoughts and active management of para-suicide/self-harming behaviors.
- Prospective client is willing to actively engage in treatment and all services that comprise
- SLUSA's trauma-informed holistic treatment model, as well as abide by the program's community expectations and our behavior support incentive program.

#### Exclusionary Criteria:

- Prospective clients with chronic/pervasive medical conditions that are not medically and/or pharmacologically stabilized (e.g. seizure disorders).
- Developmental and learning disabilities that would preclude a prospective client from benefiting from treatment and services.
- Significant limitations in independently completing activities of daily living.



### Referral Process

StreetLightUSA values community partnership and collaboration. We believe that together, we can help to make the process of commencing the road to recovery and healing a bit less challenging to clients and their families.

- A pre-screening is conducted by our referral team to assess for preliminary fit. Referrals meeting initial criteria are scheduled for a referral assessment with a clinician for final determination. (Referral assessments are completed via a HIPAA compliant tele-health platform).
  - Referrals not meeting initial criteria are provided resources and referral information as appropriate.
- Approved referrals are transitioned to our patient billing services team to confirm benefits and coverage.
- Admission date is coordinated by our referral team once insurance/payment has been confirmed.
  - We are contracted with several insurance providers, as well as with AZ AHCCCS (medicaid).
  - We also offer support in pursuing Single Case Agreements with insurance carriers and can provide information on Victim Compensation for your state.
